**FIRE SAFETY CERTIFICATE**

Certified that the Sant Nirankari Girls Sr. Sec. School, located at Sant Nirankari Colony, Delhi-110009 comprised of Ground and 02 upper floors owned/occupied by Sant Nirankari Girls Sr. Sec. School was issued Fire Safety Certificate vide this office letter no. F-6/DFS/MS/2009/3076 dated 23.10.2009. The premise was re-inspected by the officer concerned of this department on 08.05.2018 in the presence of Shri. Ashok Kumar, Vice-Principal and observed that all the fire prevention and fire safety arrangements as provided in the premise found in good working condition and there is no additional construction. The premise have therefore deemed complied with the requirements under rule 33 of the Delhi Fire Service Rules, 2010 and the building premise is fit for occupancy under Educational "Group B" with effect from 11.05.2018 for a period of three years in accordance with the rule 36 unless renewed under rule 37 or sooner cancelled under rule 40, subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

**Conditions for the validity of Fire Safety Certificate:**


1. All the fire safety arrangement provided there-in shall be maintained in good working conditions at all times.
2. Loss of life or property due to non functional fire safety measure shall be at the responsibility of the management.
3. The trained fire fighting staff should be available round the clock.
4. Any deviation with regard to the construction etc shall be verified by the concerned building sanctioning agency.
5. This certificate cannot be treated in any case for regularizations of unauthorized construction.
6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Fire & Safety (sub rule (1) of rule 37) along with a copy of this Certificate, six months prior to its expiry.
7. The owner/occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [WWW.dfs.Delhi.govt.nic.in](http://WWW.dfs.Delhi.govt.nic.in)
